As this is the last newsletter of the year, I thought I would take the opportunity to look back on the past year and look forward to 2024.

During 2023, we experienced a near record workload in all areas of the state, and the Business Representatives did a great job providing the necessary manpower to fulfill the contractors' needs. Many times, the membership was asked to travel away from home to fill these needs. On behalf of Local 18, I would like to thank those members and their families who did journey to fulfill these requests. We realize that it is a sacrifice for you and your families to travel abroad for a paycheck, but without you doing this, our contractors would not feel comfortable in bidding work and these projects would go to another trade or the non-union sector. So, again thank you!

During the past year we negotiated eleven (11) contracts, and although I am never completely satisfied, we did very well and settled record contracts. As always, your Elected Officials and the members who sat on the Negotiation Committees did a great job and worked very hard.

The Health Funds continue to provide the membership with good medical benefits. As of August 2023, the State Fund has 8.70 months of continuation value, and the Fox Valley Fund has 12.44 months of continuation value. I am happy to report that after much debate and positive information that has come out of the International Steering Committee, the retiree rates will remain the same in 2024! We still have a lot of work to do on the rates and plan design for 2025, however, the Trustees are committed to meet monthly on this issue. Please remember to contact the Health Fund Office as soon as possible any time you experience a life-changing event (marriage, divorce, birth of a child, etc.). As always make sure to open all mail received by the Health Fund Office and if you have any questions, do not hesitate to call the Fund Office.

By the time you read this newsletter,

It is hard to believe how quickly the past year has gone and we are now embarking on new journeys into the new year. Overall, it has been a good year for our members and our Local as a whole. We have had very low unemployment numbers throughout the state for the past year and we have seen our membership numbers grow a little bit as well. These are all great accomplishments as we head into the new year! We as a staff hope to see these trends continue in the year to come and hope to see even more growth in all of our contract areas, which will help provide more opportunities for members and those wanting to become members of Local 18.

I wanted to talk a little more about our Collective Bargaining Agreements (CBA). We are a statewide Local and we are split up into nine (9) different contract areas. Those are Milwaukee, Madison, Wausau, Eau Claire, LaCrosse, Janesville, Fox Valley, Racine/ Kenosha, and of course the Sheboygan/FDL/ Manitowoc and Calumet areas. As you should all know, normally every three (3) years each one of these contract areas sit down with the respective contractors in that area to negotiate a new contract for the members. This is a very important component of us being Union Sheet Metal Workers and the members involvement is critical to us making sure we get the language and raises that our membership is looking for.

It is also important that we as members know our areas CBA, as well as any other areas CBA's that you may be performing work in. The CBA is there to hold us and the contractors responsible for the provisions and rules that are spelled out in the contract. These range from wages, safety, scope of work, subcontracting, overtime pay, travel, and even apprentice ratios. There is a lot of information in that CBA that we as members need to be more cognizant of when we are performing our day-to-day duties as Union Sheet Metal Workers. I urge all of you to get to know your CBA a little better. Far too many times we have situations where something in the CBA is not being done or followed. More often than not, it is not being brought to our attention until way after the violation has occurred. This makes things much more difficult for us to deal with because of having to dig back for records that are several months or years old! This can be a time-consuming process for all involved. It can also take longer for any sort of resolution to come about because of all the back and forth between the two (2) parties to get the correct information.

So, I implore you as a member of this Union to get to know your Collective Bargaining Agreement better. If something seems out of line or does not feel like that is the way it should be, please either go to the contract book to check and if you are still not sure reach out to your Business Representative for more guidance. Then at this point, we are at least aware of what is going on and can take the proper steps towards getting things corrected or resolved in a timely manner. That way you as a member also have a clearer understanding of that particular piece of language and how it protects you as a Union Sheet Metal Worker. Just as most pro athletes would never play without a proper contract, we as Union Sheet Metal Workers have the some of the same types of protections through our Collective Bargaining Agreements. This is one of the many advantages of being in the unionized sheet metal industry. Lastly, if you do not have a copy of the Collective Bargaining Agreement or have never seen one (hopefully all of you have) please reach out to your area Business Representative and we would be more than happy to get some over to you and your place of employment.

As I wrap up my article, I would like to wish all of you and your families a Merry Christmas and a safe and prosperous New Year! As a reminder, we will have our annual Christmas Party on December 5, 2023, down at the Sheboygan Trades and Labor Hall. If you have never been to one of our Christmas parties, it is a good time! We have door prizes, great food, and it is a great place to catch up with fellow brothers and sisters that you may not run into too often in the hustle and bustle of everyday life. 

As we close on the end of the 2023 year, I have to say we have been seeing some unprecedented times for Local 18. Statewide we have been at or almost at full employment, hours have been up for both the Health Fund and our Retirement Fund. We have organized and brought in a lot of new members and have some record class sizes for the Sheet Metal and EST Programs. The Racine area now has a mega project breaking ground in Mount Pleasant. With even more projects on the radar for the future. Like was said at our International Conference by our new General President Michael Coleman, "This is our time!" We have an amazing opportunity at our fingertips with the outlook of projects coming up, and all this in our own backyard. You have the commitment from the staff of Local 18 that we will continue to fight to secure the man hours each one of these projects bring. Whether it be ductwork, architectural metal, service work, welding, and everything else in between. But all this would not be if it was not for the hard work each and every one of you do. So, hats off to all of you for the hard work you have done this year and into the future.

Some new projects have been brought to my attention and I am working to secure for Local 18 and its members. Haribo is looking to add onto the factory in Pleasant Prairie and double its size. The Menominee Tribe wants to have another go at a Hard Rock Casino in Pleasant Prairie and wants to sign a Project Labor Agreement (PLA) for this project. Kenosha wants to develop the vacant land downtown and on the old Chrysler site. Also don't forget the Racine Unified District projects that will be going on in Racine. The future for the members of Local 18 looks promising for 2024 and beyond.

Southeastern JAC has put on five (5) new apprentices for this fall, three (3) are Sheet Metal and two (2) are EST Apprentices. We now have forty-one (41) apprentices enrolled in our Apprenticeship Program. We have grown over the years and are a far cry from the small enrollment we have seen in the past. Also, we are going through our accreditation for the iTi. This is something our JAC goes through every five (5) years.

I had the opportunity to participate in a Career Fair at the Racine Fair Grounds on October 11th and 12th. This career event hosted over 1,000 middle school students and over 800 high school students. We were able to bring our virtual welder in for this event and it was a huge hit. I did get help from one of our retired members Randy Graf, who was an Instructor for our JAC for many years. This event also had many other hands-on activities for the students in many of the Building Trades Career choices.





I typically get a few phone calls this time of year for clarification on the holidays. Thanksgiving Day, Christmas Day and New Year's Day shall be recognized as holidays. If the actual holiday falls on a Saturday, the Friday immediately before it will be recognized as the holiday and will be as such, only if worked. If the actual holiday falls on a Sunday, the Monday immediately after it will be recognized as the holiday and will be paid as such, only if worked. All work performed on holidays shall be paid at double time.

Christmas Eve Day, if worked, shall be paid at one and one-half (1.50 times the regular rate after four (4) hours).

Thanksgiving Day falls on Thursday. That day is the holiday day and paid as such only if worked.

Christmas Eve is a Sunday and Sundays are recognized as a holiday and paid as such only if worked.

Christmas Day falls on a Monday, therefore that day is the holiday day and paid as such only if worked.

New Year's Day falls on a Monday, therefore that day is the holiday day and paid as such only if worked.

The Southeastern Building Trades will be hosting their 5th Annual Ice Fishing Derby on February 17, 2024 at Silver Lake Pavilion, Silver Lake in Kenosha. This Fishing Derby is open to all Building Trades members and their families. There will be food and refreshments that will be provided by the Building Trades Council. If you don't fish that is fine too, come on out and enjoy some time out with your fellow brother and sisters from Local 18 and other building trades members.



- They read the picket sign, and they leave.

• They know that once a picket line is established, their Business Representative, and other Union Officials are legally gagged and handcuffed by law from giving advice pertaining to that job. They can only tell them if the picket line is authorized.

A good union member knows their rights.

They have the right not to work behind any picket line.

- They have the right to decide for themselves whether to walk off a jobsite that is being picketed.
- They understand that even though it may not be their trade that is picketing, that it could be their trade that is under attack next.
- They know that a two-gate system means a picket line has been set up and that they have the right not to work behind that line know matter how many gates their employer or the general contractor has set up.
- Please keep the cards in your wallet. Know your rights and be prepared ahead of time to react to a picket line.

Addendum A 23 page 24

23. PICKET LINES: It shall not be considered a violation of the Agreement if an employee refuses to cross or work behind a primary picket line and no employee shall be required by the employer to cross or work behind a primary picket line of his or any other Union

On October 9th and October 11th our first-year apprentices received fire extinguisher training. J.F. Ahern did an excellent job. See picture below.



As many of you may already be aware, I serve as the President of the Building and Construction Trades Council of South-Central Wisconsin (BCTCSCW). In that role I am making an announcement that we are currently looking for a new Executive Director. Jac Weitzel whom has been our Executive Director for the past three (3) years has taken a new job with SEIU Wisconsin (Nurses Union). Her last day was November 1st. She did an excellent job opening new doors and relationships in her time with us. We are actively looking for the next person to pick up where she left off. The job description is too much to list in this article, but in short, it is a full-time salaried position working for the Building Trades and taking direction from the Building Trades Executive Board. There is preliminary discussion that may or may not be decided at the time of your reading this, of the possibility of merging the Southern and South Central Building Trades Councils into one Building Trades Council in order to be able to hire an additional full time Administrative Assistant, to help the new Executive Director with his or her administrative duties and to provide paid staff services to the Southern part of the State. 3. Exclusively for our Members: The SMART 18 Scholarship is exclusively available to our dues paying members, making it a testament to our commitment to supporting our community.

Eligibility:

The SMART 18 Scholarship is open to all active, dues paying members who meet the following criteria:

• Must be dependent children, age 25 and under or legal spouse, age 25 and under of a full-time SMART Local 18 dues paying members who have a minimum of two (2) years of membership as of the application deadline date.

*Dependent children are unmarried children and claimed as a dependent on the Plan Participant's (eligible member's) Federal income tax return.

• Be high school seniors, high school graduates or current college undergraduates.

• Plan to enroll in full time undergraduate study at an accredited two (2) or four (4) year College, University or vocational-Technical School for the entire upcoming academic year.

*Grandchildren of members are not eligible.

Application Process:

2. Complete the application, including the essay and required documentation, before the deadline on March 1, 2024.

Awards:

Essay Impact Award = one (1) award of \$6,000.00. The award will be based on overall applicant data and the top response to the essay question.

SMART Local 18 Award = nine (9) awards of \$4,000.00 each. The awards will be based on overall applicant data.

You may have noticed the optional dental coverage information included in the open enrollment material you received from the Wisconsin Sheet Metal Health Fund Office in early November. You will have the ability to opt in/out of the optional Dental Program during the open enrollment period only. If you choose to enroll in the optional Dental Program, forms are due to the Fund Office by December 1, 2023.

State Capitol Report

The Fall Session of the State Legislature has been underway since early September and it's been a nonstop flurry of legislative action.

Of greatest interest to Local 18 are two (2) companion bills that would provide funding to the Southeast Wisconsin Professional Baseball Park District for improvements to American Family Field. The original bill, introduced by Republicans in the legislature included a significant State Funds contribution and also required a large contribution from Milwaukee and Milwaukee County, as well as a contribution from the Brewers. The original bill was opposed by local officials and many lawmakers alike due to the negative impact on the City and County's budgets.

However, a compromise was reached based on the reduction of excess administrative fees that the state was receiving from local sales tax collection. By proposing a reduction in those excess fees that all local governments that impose a local sales tax have been paying, it created an avenue for the City of Milwaukee and Milwaukee County to provide local support without absorbing any negative impact on their current budgets. Further, all other counties in Wisconsin that impose their own Sales Tax (68 out of 72 counties) will be able to keep more of what they collect. The proposed deal will benefit all of those counties right away and once the stadium district funding agreement term is over, Milwaukee and Milwaukee County will be able to keep more of its local sales tax revenue going forward. In addition, to requirements to look at ways to expand development around the ballpark and some other provisions the County sought, this looked to be a

win-win for all. It passed the State Assembly on a bipartisan vote of 69 to 27.

The Bill is now in the State Senate where additional amendments are being considered that would include a greater contribution from the Brewers, less state funding, a ticket tax on non-Brewers events, and an audit of the stadium district board.

The Brewers relationship with organized labor has been strong and that's why SMART #18, all of the other Building Trades, and the Unions who represent workers at the ballpark like SEIU and Workers United, support the current deal. I'm hoping by the time you read this we'll have ensured that the Brewers stay in Wisconsin for another generation and that Local 18 members continue to get work at the ballpark.

In other news, we continue to advocate in favor of initiatives to require contractors who are awarded work on state projects to employ a proportionate share of apprentices. We believe this is an important way to help sustain a safe, efficient, and reliable construction industry in Wisconsin for generations to come. We expect a rule requiring such a threshold to move forward in the administrative rulemaking process shortly.

We also continue to work to advance Fire Life Safety initiatives and indoor air quality initiatives. While there are always some bad bills that we continue to oppose, they haven't moved much lately, so I get to keep it positive this newsletter. Thanks and have a Merry Christmas and Happy New Year.

WHEN MAKING A WORKER'S COMPENSATION CLAIM THE LIKELIHOOD OF SUCCESS HINGES ON THE DETAILS

Giving a complete work injury history to your doctor is the most critical part of a worker's compensation claim. Your worker's compensation claim is no stronger than your medical support. Your injury history, as documented by your doctor, is of vital importance if your employer has little or no history of the injury occurring. It is your reporting to the doctor of what happened and the doctor's timely medical treatment that give you the needed credibility to successfully pursue a worker's compensation claim.

Giving a poor injury history to your doctor will affect your credibility at hearing before an administrative Law Judge (ALJ). Therefore, take whatever time is necessary at your initial visit to give a complete history to your doctor. It's also important to restate your history each time you see a doctor so that the doctor's chart notes, which are generally admitted for the ALJ's review, are complete and reflect that your injury occurred at work. The ALJ will decide your case based on your credibility at the hearing but will also make a determination as to whether your doctor's opinion makes sense based on what you told your doctor while you treated for your injury.

Do not hesitate to report earlier injuries to the same part of your body. For example, in a back injury, if you have had earlier back problems, draw distinctions between the earlier problems and your current symptoms. If you have healed and there have been no symptoms from your earlier back problems, tell the doctor how often and under what circumstances the earlier injury bothered you, and how the current injury differs. Be precise and explain the location, amount and consistency of pain. If you have a repetitive work-related injury, make sure the doctor understands the nature of your work. It's very likely that your doctor lacks knowledge of the heavy demands of your job. Describe your workplace and job tasks thoroughly. Demonstrate your job to the doctor, and then give him/her ranges of weights and the number of repetitions performed in a shift. As an example, if you have to make a certain movement lifting 20 pounds, 300 times in a shift, explain and show the doctor those movements. Or, if you handle 20,000 pounds of product in a shift, detail the size of the objects and the movement necessary to move those objects. If you provide this information, the doctor will understand and appreciate how and why your job has physically affected you over the years.

This will help prevent a delay in prescription drug deliveries and other services.
